


ANALYSIS OF SURVEY RESPONSES



Q.1. How satisfied are you with the various citizen-centric services offered by the Odisha government?

Analysis of Responses

Approximately 17.2% of respondents indicated being 'Neutral', while 7.5% reported being 'Dissatisfied', and 3.3% expressed being 'Very Dissatisfied'. These findings suggest that while the government has made commendable strides in meeting citizen needs, there remain areas for improvement to address the concerns of those who are not fully satisfied with the current services.

Recommendations for Action

To build upon the positive sentiment expressed by the majority of respondents and address the concerns of those with neutral or negative views, it is recommended that the Odisha government undertake the following actions:

> Conduct in-depth analyses to identify specific areas of dissatisfaction and prioritize improvement efforts accordingly.


> Enhance communication and outreach efforts to ensure that citizens are aware of the full range of services available to them.

Insights and Implications




Insights and Implications

Foster collaboration between the government and private sector healthcare providers to leverage resources, improve service delivery, and expand healthcare coverage.





Q3 (a). If yes, what are the areas you have seen improvement?














Q6. In your opinion, has the state of Road Transport in Odisha improved over the past 5 years?

- > Strengthen coordination and collaboration among government agencies, transport authorities, and other stakeholders to ensure integrated and sustainable approaches to road transport development and management.



To address the concerns raised by respondents who do not perceive improvements or are uncertain about the state of employment opportunities in Odisha, it is recommended that the government consider the following actions:


- > Conduct comprehensive assessments to understand the underlying factors contributing to the mixed perceptions of employment opportunities.






Q10. In your opinion, has the state of the Sports sector in Odisha improved over the past 5 years?






> Foster inclusivity, transparency, and accountability in the electoral process to ensure fair and free elections and uphold the democratic principles and values of the state.

Additionally, a significant proportion of respondents emphasized the importance of Healthcare (22.6%), control on crime (19.6%) and bringing more investment and supporting industrial growth (14.5%) as next government's focus areas.

Insights and Implications

High priority on job creation and healthcare signals the urgency to address unemployment issues and public health challenges respectively to tackle unemployment, poverty, and socio-economic gaps, and ensure quality healthcare access. Additionally, prioritizing IT & Technology acknowledges its pivotal role in driving innovation and growth. Concerns over crime and industrial growth underscore the call for robust law enforcement and strategies to boost investment, business, and employment prospects.

Recommendations for Action

To address the diverse priorities identified by respondents for the focus areas of the next government, it is recommended that the Odisha government consider the following actions:

> Develop and implement comprehensive healthcare policies to enhance accessibility, affordability, and quality of services, addressing public health challenges effectively.

> Strategize initiatives for job creation, skill enhancement, and entrepreneurship to provide educational and employment avenues, particularly for marginalized groups and youth.

> Expand social welfare schemes to combat poverty, hunger, and social exclusion, ensuring equitable access to essential services for vulnerable communities.

> Strengthen law enforcement, enhance crime prevention measures, and promote community policing to bolster public safety and uphold the rule of law effectively, while also fostering industrial development.
